\$59,000 IN COLLEGE SCHOLARSHIPS AWARDED TO JUNIOR GOLFERS

Over the past 11 years, the Kelly Gibson Foundation along with its community partners have awarded \$655,800 in scholarships to 281 recipients.

All members of the KGJGT who are at least juniors in high school are eligible to receive scholarships.

The Kelly Gibson Foundation was founded as Feed the Relief, Inc. by Kelly and Elizabeth Gibson in September of 2005 with the idea of providing necessary support for the front line first responders to Hurricane Katrina.
